

CREDENTIAL REVIEW for PRIOR LEARNING ASSESSMENT

At Central Maine Community College, a student may qualify to receive academic credit for by presenting proof of a current and valid professional credential designed to assess the student's knowledge in a field. Credential review is subject to applicability to the student's program of study. Eligibility: Students must be registered, matriculated at CMCC. Bring original, current, valid credentials to the Registrar's Office or to the Associate Dean of Academic Affairs. Official transcripts or training materials may be required.
