

PRIOR LEARNING ASSESSMENT: CREDENTIAL REVIEW

At Central Maine Community College, a student may qualify to receive academic credit by presenting proof of a current and valid professional credential or license designed to assess the student's knowledge in a field. Credential review is subject to applicability to a student's program of study. Eligibility: Students must be registered and matriculated at CMCC. Credentials/licenses must be current and not expired.
